## INFORMATION ABOUT DONATIONS AND TAX CREDITS FROM INLAND REVENUE

The Royal New Zealand Ballet is a charitable trust registered under the Charitable Trusts Act 1957 (registration number CC25091). The Inland Revenue Department allows individuals to claim 33.33% rebate for all donations up to the value of their income.

### Special note for Dress Circle Supporters

**from \$1,000:** The IRD does not consider a contribution to be a charitable donation if it is given in exchange for material benefits (those with a monetary value), such as performance tickets arranged by the RNZB (valued at \$115 per ticket and \$10 per programme). The value of those benefits cannot be considered part of a donation and do not qualify for a donation tax credit. Other benefits – such as attending a company class, visiting the workshop, or being recognised in the programme – are not considered material and do not affect a donation's qualification for a tax credit.

Supporters from \$1,000 who wish to claim a tax credit for the full value of their contribution may decline material benefits at the time of their gift or may direct their gift to the Annual Appeal.
