### **RNZB Competitions: Terms and Conditions**

2. ELIGIBILITY: Employees and their immediate families of RNZB are not eligible to enter.
3. HOW TO ENTER: Entry is Free.
  - 3.a For the 'Get Involved' competition, entrants must register for the RNZB email newsletter, either online or using the form found in your programme,
4. DATES: Entries must be received by:

7. PRIZE DELIVERY: Prize tickets can be collected from the venue OR Tickets will be sent by post. RNZB is not liable for damage to prizes sent by post or courier.
8. NO CORRESPONDENCE: RNZB's decision regarding the Winners is final and no correspondence will be entered into.
